

ABOUT THE NOMINEES

Those nominated for the 2014 list hailed from all areas of the mortgage servicing industry, from practicing attorneys to entrepreneurs and individuals in marketing, operations, compliance and business development roles. Each young professional nominated this year is employed by an ALFN member in one of the association's membership categories: attorney/trustee, associate or servicer.

Readers may notice that some of the individual's profiled this year are not young professionals just starting their careers, but experienced and well-known leaders in their fields. That's because the ALFN JPEG program has been widely supported by such individual's who've taken on mentor and leadership roles to share their knowledge and experience. For that, we thought they deserved recognition as well, because the young professionals profiled here aren't starting from scratch—they're picking up where others have left off.

ABOUT JPEG

In mid-2013 the ALFN launched its first young professionals network, the Junior Professionals & Executives Group, or JPEG. Led by a group of dynamic and energetic founding members, JPEG launched a series of networking mixers, a mentor matching program, held regular teleconference meetings and spearheaded the production of this list: the Picture the Future list.

Designed to showcase mortgage servicing's top young professionals who are committed to the industry, our inaugural list sets the bar high. The individual's profiled here are making a difference at firms, businesses and servicers large and small. They are volunteering their free time to make their communities better places to live. They are going the extra mile professionally by developing educational tools, working with industry partners to drive best practices, and actively sharing their knowledge and expertise to improve processes, outcomes and results.

THE SELECTION PROCESS

All nominations were received during a two week period in a process that was open to any employee of an ALFN attorney/trustee, associate or servicer member. Individuals could either self-nominate or were nominated by a third-party.

Nominations were then anonymized by removing any references to firm or company names, individual names and references to gender or other identifiers. Seven industry leaders who are experts in various facets of mortgage servicing joined our Review Committee and parsed the list of nominees down to the 14 we've featured here. No reviewers were affiliated with any of the firms, servicers or associate members where nominees were employed.


Jennifer believes in the "client-first" way of doing business. As relationships grow and needs change, she says "you have to check in on your clients, know their needs, and always treat them

She later tackled the CFPB and the Fair Debt Collection Practices Act by co-authoring a cover story for a leading trade publication.

When asked about her habit of volunteering for the harder stuff, Lindsey put it like this: "From the Main Street courtroom to the K Street Corridor, increased regulation of the financial services sector has decidedly changed the landscape of the mortgage and default servicing industries." Then she added, "To do my job, I should be able to contextually frame how my client is regulated, any anticipated changes to those regulations, and how those regulations and changes may impact my client."

We asked her about JPEG, too. "I hope to see JPEG become a nationally recognized group and to look back and say I was part of its inception." She added, "It will be important to continue to involve more experienced practitioners to help our cause."

McCormick's assessment was correct: she's a woman with a plan. And before we concluded, Kimberly let us in on part of it: "Our biggest need is upward leadership, so that we may in turn, become the leadership of ALFN one day."


